#### THE REQUEST FOR REVIEW

M/s Pinnie Agency Limited (hereinafter referred to as "the Applicant") lodged a Request for Review dated 7<sup>th</sup> December 2020 and filed on even date together with a Statement in Support of the Request for Review sworn on 7<sup>th</sup> December 2020 and filed on even date and a Further Statement sworn on 21<sup>st</sup> December 2020 and filed on even date, through the firm of Gerivia Advocates LLP, seeking the following orders: -

- i. An order annulling and setting aside the Respondent's decision awarding Tender Number MTIHUDPW/SDHU/SUD/010/2020-2021 Social Housing at Meteorological Site for Proposed Civil Works for Roads and Other External Works (LOT 2);
- ii. An order annulling and setting aside the Respondent's letter dated 26<sup>th</sup> November 2020 notifying the Applicant that it had not been successful in Tender Number MTIHUDPW/SDHU/SUD/010/2020-2021 Social Housing at Meteorological Site for Proposed Civil Works for Roads and Other External Works (LOT 2);
- iii. An order declaring that the Procuring Entity failed to evaluate the Applicant's bid at the financial evaluation stage in

- accordance with the criteria and procedures under the Tender Document and the provisions of Sections 80 (2) & 82 of the Act;
- iv. An order directing the Procuring Entity to re-admit the Applicant at the financial stage and to carry out a re-evaluation at the financial stage whilst observing and applying the criteria in the Tender Document as required by Sections 80 (2) 82 of the Act or in the alternative, an order directing the Respondent to redo or correct anything within the entire procurement process found to not have been done properly to ensure compliance with the law;
- v. An order compelling the Respondent to pay the costs arising from/and incidental to this Request for Review to the Applicant; and
- vi. Such and further orders as the Board may deem fit and appropriate in ensuring that the ends of justice are fully met in the circumstances of this Request for Review.

In response, the Respondent addressed a letter dated 10<sup>th</sup> December 2020 and filed with the Board Secretary on 16<sup>th</sup> December 2020 in response to the Request for Review while the Interested Party lodged a Replying Affidavit sworn on 18<sup>th</sup> December 2020 and filed on 21<sup>st</sup> December, a Notice of Motion dated 23<sup>rd</sup> December 2020 through a Certificate of Urgency filed on 24<sup>th</sup> December 2020 and a Further Affidavit sworn on 23<sup>rd</sup> December 2020 and filed on 24<sup>th</sup> December 2020 through the firm of HMS Advocates LLP.

In a letter dated 21<sup>st</sup> December 2020 addressed to the Board Secretary, the Applicant's Advocates expressed the Applicant's willingness to withdraw the instant Request for Review as follows: -

Upon receipt of the said withdrawal notice, the Board Secretary, through a letter dated 21<sup>st</sup> December 2020, informed the Applicant of the requirements for withdrawal of a Request for Review as specified in Regulation 216 of the Public Procurement and Asset Disposal Regulations, 2020 (hereinafter referred to as "Regulations 2020") as follows: -
