#### **CONSENT ORDER**

On 2<sup>nd</sup> June 2023, Powermax International Limited Jv Hengtong Optic Electric Company Limited, the Applicant herein, filed a Request for Review No.35 of 2023 dated 2<sup>nd</sup> June 2023 together with a Supporting Affidavit sworn on even date by SILVESTER KIBIWOTT KINYOR, the Applicant's Director, through the firm of Marlene A.Abong'o & Co Advocates with respect to the subject tender (hereinafter referred to as the 'instant Request for Review') seeking the following orders:

- 1. The Tender Opening Minutes as well as tender pre-bid minutes be provided to the Applicant as required by the tender document and pursuant to the letter dated 26th May 2023.
- 2. The Letter of Notification of Intention to Award to the Interested Parties dated 16th May 2023 with respect to Tender No. ICTA/OT/14/2022-2023 for Procurement of Digital Super Highway Fibre Optic Cable and Associated Accessories (Framework Contracting) be nullified and set aside.
- 3. The Letter of Notification of Intention to Award to the Applicant and other unsuccessful tenderers dated 16th May 2023 with respect to Tender No. Tender No. ICTA/OT/14/2022-2023 for Procurement of Digital Super Highway Fibre Optic Cable and Associated Accessories (Framework Contracting) be nullified and set aside.
- 4. The Honourable Board finds and holds that the Applicant had a legitimate expectation that the 1st and 2nd Respondents would consider tenders whose bid price was quoted in either USD or KES as resolved in the pre-bid meeting.
- 5. The Honourable Board finds and holds that the Addendum No.2 of 27th March 2023 was not properly availed to bidders, having been uploaded on the "Archives" section of the Respondents' website as opposed to "Open Tenders" section where all bidders would have easily accessed it.
- 6. An order does issue directing the Respondents' Evaluation Committee to reinstate the Applicant's tender at

the Financial Evaluation Stage and to re-evaluate the Applicant's tender price in accordance with the clarification offered to the Applicant during the pre-bid meeting and in accordance with the law.

- 7. In the alternative, an order does issue that the Applicant be added to the list of successful bidders including the interested parties herein on account of having presented the lowest tender price, albeit quoted in United States Dollars (USD)
- 8. The 1st Respondent to pay the cost of the Review.
- 9. Any other orders as necessary for the ends of justice.

In a Notification of Appeal and a letter dated 2<sup>nd</sup> June 2023, Mr. James Kilaka, the Acting Secretary of the Board notified the Respondent and the Procuring Entity of the filing of the instant Request for Review and the suspension of the procurement proceedings for the subject tender, while forwarding to the Respondent a copy of the Request for Review together with the Board's Circular No. 02/2020 dated 24<sup>th</sup> March 2020, detailing administrative and contingency measures to mitigate the spread of COVID-19. Further, the Respondent was requested to submit a response to the instant Request for Review together with confidential documents concerning the subject tender within five (5) days from 2<sup>nd</sup> June 2023.

On 9<sup>th</sup> June 2023, in opposition to the Request for Review, the 1<sup>st</sup> and 2<sup>nd</sup> Respondents filed a Replying Affidavit sworn on 8<sup>th</sup> June 2023 by Stanley Kamanguya, the Chief Executive Officer of the 2<sup>nd</sup> Respondent (hereinafter

referred to as "the Respondents' Replying Affidavit) together with a file containing confidential documents concerning the subject tender pursuant to Section 67(3)(e) of the Act.

Vide letters dated 9<sup>th</sup> June 2023, the Acting Board Secretary notified all tenderers in the subject tender via email, of the existence of the instant Request for Review while forwarding to all tenderers a copy of the Request for Review and the response by the Respondent together with the Board's Circular No. 02/2020 dated 24<sup>th</sup> March 2020. All tenderers in the subject tender were invited to submit to the Board any information and arguments concerning the subject tender within three (3) days from 9<sup>th</sup> June 2023.

Vide a Hearing Notice dated 13<sup>th</sup> June 2023, the Acting Board Secretary, notified parties and all tenderers in the subject tender of an online hearing of the instant Request for Review slated for 15th day of June,2023 at 12:00 noon, through a link availed in the said Hearing Notice.

None of the parties filed written submissions.

Before the matter came up for hearing on 15th day of June,2023, the Applicant filed notice of withdrawal dated 15<sup>th</sup> June,2023 confirmed that it does not wish to proceed with the matter. The Board directed parties to file consent as required by the regulations.

On 15<sup>th</sup> June 2023, the Applicant's advocates filed, a Notice of Withdrawal of Request for Review by Consent dated 15<sup>th</sup> June 2023 and filed with the Board on the 16<sup>th</sup> June,2023 signed by both the Advocate for the Applicant and the Advocate for the 1<sup>st</sup> and 2<sup>nd</sup> Respondent and one of the Interested Party .The 2<sup>nd</sup> and 3<sup>rd</sup> Interested Party had neither entered appearance nor filed any documents in the response to the instant Request for Review. The Consent reads:
