- 4. Vide email dated 29<sup>th</sup> August 2024, parties were notified that hearing of the matter had been rescheduled to Friday, 30<sup>th</sup> August 2024 at 11.00 a.m.
- 5. At the hearing of the instant Request for Review on 30<sup>th</sup> August 2024, both counsels for the Applicant and Respondents informed the Board that they wished to file a consent and have the matter marked as withdrawn.
- Subsequently, a Consent Order dated 30<sup>th</sup> August 2024 and signed by all parties' respective advocates on record was equally filed with the Review Board on 30<sup>th</sup> August 2024 pursuant to Regulation 216(2) of Regulations 2020.
- 7. In the circumstances, the Request for Review dated 14<sup>th</sup> August 2024 and filed on even date is deemed to have been withdrawn on 30<sup>th</sup> August 2024 by consent of parties.
